- A second Open House (generally in the late fall) will include an opportunity to meet with Title I teachers and inquire any information regarding the Title I program at Duffield Primary School. Invitations to attend are sent to parent of specific students receiving Title I remediation services.
 - C. Offer flexible meetings, such as meetings in the morning or evening, and provide, with funds provided under this part, transportation, child care, or home visits, as such services related to Parent and Family Engagement.  - During open houses, parent/ teacher conferences and classroom visits, DPS teachers will provide information on curriculum used.
 - Informational letters regarding SOLS, PALS and benchmark testing will be distributed by teachers prior to testing.
- if requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practically possible.
 - Families will be encouraged to contact classroom/Title I teachers with any concerns regarding their child's progress throughout the school year.
 - The meeting times will be flexible to accommodate the schedules of families.
